

IN THE DISTRICT COURT OF JOHNSON COUNTY, KANSAS

ADMINISTRATIVE ORDER NO. 3

PERTAINING TO THE DESTRUCTION, RETENTION FOR USE, OR SALE OF
UNCLAIMED EXHIBITS PURSUANT TO KANSAS SUPREME COURT RULE 108.

Now, on this 1 day of October, 1996, there comes on before the Administrative Judge of the Tenth Judicial District, the matter of the destruction of certain court records pursuant to Kansas Supreme Court Rule 108. After due consideration, the Court finds:

1. Court exhibits have accumulated in the custody of the Clerk of the District Court from approximately 1965 to 1990.
2. The Clerk of the District Court has provided this Court with a complete and thorough inventory of all such exhibits in her custody. Said inventory is attached and made a part of this Order by reference.
3. The Clerk has made diligent effort to return these exhibits to known agencies. Items that have been returned are reflected on the attached receipts.
4. All weapons, drugs, and currency found to be among these exhibits have been placed in the secured property storage facility of the Sheriff of Johnson County, Kansas, to be held for an Order of destruction from this Court.
5. The Johnson County District Attorney has reviewed this inventory and clearly marked those items that should be retained for possible future prosecution. The inventory so marked by the District Attorney is attached.
6. A list of tools and other usable items is attached. Said items will be offered for sale in the next county auction. The proceeds of any sales will be deposited in the county general fund.

The Court determines that no further notice is required and finds that all exhibits marked for destruction on the attached inventory should be destroyed by supervised shredding, burning, or other methods appropriate for the type of exhibit to be destroyed.

IT IS THEREFORE THE ORDER OF THIS COURT that the Sheriff of Johnson County, Kansas, proceed with the destruction of all weapons and drugs delivered to his custody and to deposit said currency into the county general fund, and that the Clerk of the District Court proceed immediately with the destruction of those exhibits marked for destruction. The Sheriff and the Clerk will each make a return to this Court of the time and method of disposal. Further, the Clerk will maintain a permanent record of all exhibits retained or destroyed pursuant to this Order.
