SHERIFF'S RETURN OF SERVICE

On Thursday, December 24th, 1998, @ 1129 a.m. Sheriff's Deputies executed an Administrative Order issued by Judge Larry McClain, directing the Sheriff to enter into the residence located at **7120 Linden, Prairie Village, Kansas, and to locate any client files present in the residence and seize those files and return them to the court.**

Entry was made into the residence through an unlocked window. Mr. Dennis was not present during our time inside. This order was executed and any files that appeared to contain 1997-98 court case documentation were seized and removed. The items were inventoried and photographed prior to being removed. (Video Taped). All property was transported to the Johnson County Courthouse and placed in Judge McClain's Jury Room, Court #10, per verbal order of Judge McClain. The Jury Room was secured and the door was sealed by tape and a notice of **NO ENTRY** was posted outside on the door.

A stamped certified copy of the Administrative Order and a copy of the inventoried items taken, were posted on the inside of the residence's entry way wall.
