MOTION TO DISPOSE OF PROPERTY

The Johnson County Sheriff's Office moves the court for an order granting it leave to dispose of certain property acquired pursuant to court orders. In support of this motion, the movant states:

1. The Johnson County Sheriff's Office has received and taken control of certain items of personal property under court orders in Protection from Abuse cases and in divorce cases filed in Johnson County Kansas. That property, relating to 272 cases filed between 1992 and 2001, is listed in the attached Exhibit A.
2. The Plaintiffs in those actions have been notified that the Sheriff's Office has possession of those items, and that they have five days after the Sheriff's Office took possession of said properties to reclaim them from the Johnson County Sheriff's Office, Civil Division.
3. These items of property have never been reclaimed by the Plaintiffs, and the Sheriff's Office is still in possession of these items of property.

WHEREFORE, the Johnson County Sheriff's Office requests an order of the court directing and authorizing the Sheriff's Office to dispose of all properties listed on Exhibit A. Movant further requests an order permitting the Johnson County Sheriff's Office, after the expiration of six months, to dispose of such other property it acquires in the future under similar circumstances in Protection From Abuse and Divorce actions.


