ADMINISTRATIVE ORDER NO. 03 - 5

Based upon information received from the Office of the Disciplinary Administrator, the clients of attorney Gordon M. Rock, Jr. are being neglected. Therefore, pursuant to Kansas Supreme Court Rule 221, Joseph R. Horgan, an attorney engaged in the private practice of law in this judicial district, is hereby appointed to forthwith contact Mr. Rock and to request that he voluntarily permit Mr. Horgan to inventory and review all of Mr. Rock's client files in accordance with this administrative order; or, in the absence of Mr. Rock's cooperation, to obtain and inventory any client files of Mr. Rock in the possession of Donald L. Zemites, Esq., 750 Ann Avenue, Kansas City, Kansas 66117; to report to the court on the status of the files obtained; and, subject to the approval of the chief judge, to take such further action as may be necessary to protect the interest of Mr. Rock and his clients.

Mr. Horgan is authorized to review all files of Mr. Rock; to open all mail addressed to Mr. Rock which appears to relate to cases or matters of clients; and to respond to any clients of Mr. Rock who have inquired about the status of their cases.

If instructed to do so by a client of Mr. Rock, Mr. Horgan shall return to such client the client's file and related documents, provided that the file and documents are first copied and the copies retained by Mr. Horgan.


