ADMINISTRATIVE ORDER NO. 04-4

Re: Bradley A. Peterson, Esq.

Based upon information received from the Office of the Kansas Lawyers Assistance Committee, the clients of Bradley A. Peterson may be neglected due to Mr. Peterson's illness, which is expected to be of extended duration. Therefore, pursuant to Kansas Supreme Court Rule 221, John C. Betts, an attorney engaged in the private practice of law in this judicial district, is hereby appointed to forthwith contact Mr. Peterson and to request that he voluntarily permit Mr. Betts to inventory and review all of Mr. Peterson's client files in accordance with this administrative order; or if personal contact is not practical, to obtain and inventory any client files of Mr. Peterson in the possession of Drew Frackowiak, Esq., 6750 W. 93rd Street, Suite 220, Overland Park, Kansas 66212; to report to the court on the status of the files obtained; and, subject to the approval of the chief judge, to take such further action as may be necessary to protect the interest of Mr. Peterson and his clients.

Mr. Betts is authorized to review all files of Mr. Peterson; to open all mail addressed to Mr. Peterson which appears to relate to cases or matters of clients; and to respond to any clients of Mr. Peterson who have inquired about the status of their cases.

If instructed to do so by ^{A client of Dr.} Mr. Peterson, Mr. Betts shall return to such client the client's file and related documents, provided that the file and documents are first copied and the copies retained by Mr. Betts.

Mr. Betts shall not disclose any information contained in any of the files, records or correspondence maintained by Mr. Peterson except as may be necessary to carry out the provisions of this Administrative Order.




