proper representation of the clients of Nancy R. Ryan: to inventory all client files and to take all necessary actions to protect the interests of such clients as may be necessary, including, but not limited to, authorization to transfer any pending legal matters for such legal representation of clients to other duly licensed attorneys for the purpose of handling such client matters as may be necessary; to take any such action as may be necessary to protect the interest of Nancy R. Ryan and the clients of Nancy R. Ryan and Ryan Law Firm, LLC; to negotiate checks and any other negotiable instruments which may be payable to Nancy R. Ryan or Ryan Law Firm, LLC as attorney representing such clients or related to the operation of Ryan Law Firm, LLC; to withdraw and/or disburse any funds in the operating account of the law practice maintained by and in the name of Nancy R. Ryan; to take any and all other necessary actions for the proper management and administration of the law practice of Nancy R. Ryan in order to timely conclude all legal and administrative work related to the representation of clients and the financial matters of such law practice; and any other actions which may be necessary for the management and control of the law practice of Nancy R. Ryan.

IT IS, FURTHER, BY THE COURT, CONSIDERED, ORDERED, ADJUDGED AND DECREED that Thomas P. Mitchelson shall be authorized to take all necessary actions on behalf of Nancy R. Ryan to protect the interest of all clients of Nancy R. Ryan pursuant to Kansas Supreme Court Rule 221.
