K.S.A. 38-2312

NON-EXPUNGEABLE:

- capital murder
- murder in the first degree
- murder in the second degree
- voluntary manslaughter
- involuntary manslaughter
- involuntary manslaughter while driving under the influence of alcohol or drugs
- rape
- aggravated criminal sodomy
- aggravated indecent liberties with a child
- indecent liberties with a child
- aggravated indecent solicitation of a child
- indecent solicitation of a child
- sexual exploitation of a child
- aggravated internet trading in child pornography
- internet trading in child pornography
- aggravated incest
- endangering a child
- abuse of a child

NOT ELIGIBLE:

Anyone who is still registered as an offender in KS

ELIGIBILITY REQUIREMENTS:

1. 2 years since final discharge
Exceptions: dismissed cases & misdemeanor diversions are immediately eligible 2. No subsequent convictions (other than traffic violations)
Exceptions: (old) municipal misdemeanors may be overlooked
3. No pending proceedings

FILING FEE: \$195.00 per case
